The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

On 27 November 2013 (“First Date of Sale”)

The order of priority for selection of residential properties on the First Date of Sale among persons who have already submitted a Registration of Intent* (each a “**Registrant**”) will be determined by balloting. Details are as follows.

1. The computer balloting will take place on 26 November 2013 after 6:00 p.m. at the Sales Office. Registrants (if the registrant is a company which should be incorporated in Hong Kong, then any one of its directors) are welcome to view the computer balloting. Every Registration of Intent shall be allotted such number of lot(s) which equals the number of specified residential property(ies) which the registrant(s) intends to purchase as indicated in the Registration of Intent less the number of specified residential property(ies) (if any) that has/have been purchased under that Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void. **The Registration of Intent from individual persons (other than the company(ies)) shall have priority in the balloting over the Registration of Intent from the company(ies). The draw shall take place in the following order, firstly from the lots allocated to those Registrations of Intent submitted by the individual persons (other than the company(ies)) and then, after completion of balloting for the aforesaid Registrations of Intent, from the lots allocated to those Registrations of Intent submitted by the company(ies).** The ballot results, including “registration number” stated on the Registration of Intent, “balloting result priority” and “attending time slot for Registrants” (each such time slot will commence after 9:00 a.m. on the First Date of Sale) will be posted at the Sales Office at 7:30 p.m. on 26 November 2013. Registrants will not be separately notified of the ballot results.
2. Each Registrant (if the registrant is a company which should be incorporated in Hong Kong, then any one of its directors) shall personally attend the Sales Office on the First Date of Sale

according to the respective “attending time slot for Registrants” of that Registrant according to the aforesaid ballot results. Registrants must bring along their H.K.I.D. Card(s) or Passport(s) (as the case may be) (for personal Registrants) or a copy of Business Registration Certificate and Registers of Directors, the director’s H.K.I.D. Card(s) or Passport(s) and the company chop (for corporate Registrants) and the copy of the Registration of Intent bearing the “registration number”. Registrants whose identities have been confirmed and verified by the Vendor shall be eligible to select the residential properties which are still available at the time of selection in the order of the aforesaid “balloting result priority”, provided that a corporate Registrant shall not select any residential property covered by Price List No.1 (which includes the revised price list(s) thereof (if any)) of Phase 2 of the Development. Any Registrant who arrives at the Sales Office at any time later than the respective “attending time slot for Registrants” of that Registrant shall not be eligible to select the residential properties in the order of priority according to the ballot results.

3. Each Registrant will be entitled to purchase a maximum of 2 residential properties (if that Registrant has indicated in the Registration of Intent concerned the intention to purchase 2 residential properties and has submitted the correct number of cashiers’ orders) or a maximum of 1 residential property (if that Registrant has indicated in the Registration of Intent concerned the intention to purchase 1 residential property and has submitted the correct number of cashiers’ orders).
4. The company which is not incorporated in Hong Kong, will not be entitled to submit Registration of Intent and purchase the specified residential properties listed herein. This restriction applies on First Date of Sale and thereafter.

After the completion of the selection of the residential properties by the Registrants as aforesaid, the order of priority in the selection of the remaining residential properties will be on a first come first served basis (but the order of priority in the selection of the remaining residential properties among all potential purchasers arriving within the first 5 minutes immediately after the selection of the residential properties by the Registrants as aforesaid is to be determined by another balloting).

In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person. The Vendor also reserves its right to revise the time of conducting computer balloting, posting ballot results and selection of residential properties respectively in accordance with the progress of confirmation and verification of identities of Registrants or attending other necessary procedures.

2013年11月27日（「出售首日」）：

各已遞交購樓意向登記表格*之人士（「登記人」）於出售首日揀選住宅物業的優先次序以抽籤方式決定。詳情如下。

1. 電腦抽籤程序將於 2013 年 11 月 26 日下午 6 時後在售樓處進行，歡迎登記人(如登記人為公司(必須在香港註冊成立)，則任何一董事)到場參觀。每一份購樓意向登記表格可獲分配的籌的數目，相等於登記人於該購樓意向登記表格內填寫的意欲購買的指明住宅物業數目減去根據該購樓意向登記表格已購買的指明住宅物業的數目(如有)。當一個籌獲抽中，其相關購樓意向登記表格的其他籌(如有)將會取消及作廢。在抽籤程序中，由私人名義遞交之購樓意向登記表格將較公司名義遞交之購樓意向登記表格優先。抽籤會以下列次序進行，首先由私人名義遞交之購樓意向登記表格所獲分配的籌中抽出，當完成以上抽籤之後，才由公司名義遞交之購樓意向登記表格所獲分配的籌中抽出。抽籤結果包括購樓意向登記表格上的「登記號碼」、「抽籤結果次序」、及「登記人報到時段」（每一個該等時段均於出售首日上午 9 時後開始），將於 2013 年 11 月 26 日下午 7 時 30 分於售樓處公布。登記人將不獲另行通知抽籤結果。
2. 登記人(如登記人為公司(必須在香港註冊成立)，則任何一董事)須於出售首日按照上述抽籤結果中所指示的相關「登記人報到時段」攜同（如登記人屬個人）其香港身份證或護照（視屬何情況而定）或其（如登記人屬公司）商業登記證副本、董事名冊副本、董事身份證或護照及公司印章、及載有「登記號碼」之購樓意向登記表格副本親臨售樓處，經賣方確認並核實身份後方可有資格根據上述「抽籤結果次序」揀選於當時仍可供揀選的住宅物業（惟如登記人為公司，則無權揀選 1 號價單(包括其經修改的價單(如有)，所包含之發展項目第二期的任何住宅物業)。登記人如於其相關上述「登記人報到時段」後才到達售樓處，將被取消根據抽籤結果次序揀選住宅物業的資格。
3. 每個登記人可認購最多兩個住宅物業（如登記人於其購樓意向登記表格表示意欲購買兩個住宅物業並已遞交正確數目之銀行本票）或最多一個住宅物業(如登記人於其購樓意向登記表格表示意欲購買一個住宅物業並已遞交正確數目的銀行本票)。
4. 非香港註冊成立之公司無權遞交購樓意向登記表格和購買所列之指明住宅物業。此限制適用於出售首日及之後。

登記人以上述形式認購完畢後，尚餘之住宅物業將以先到先得形式發售，但上述登記人揀選住宅物業完畢後首5分鐘內到達之所有準買家，則以另一次抽籤決定揀選尚餘住宅物業之優先次序。

(a) The time and manner for the submission of the Registration of Intent and the documents and materials required, etc. are specified in that form. Please refer to the form of the Registration of Intent for details. Generally:

遞交購樓意向登記表格之時間和方式及所需文件材料等於該表格中有所說明。詳情請參閱購樓意向登記表格。概括而言：

(i) In addition to copies of specified identification documents, cashiers' order(s) must be submitted together with the Registration of Intent. The number of cashiers' order(s) that a Registrant shall submit is the same as the number of residential property(ies) that the Registrant intends to purchase. The amount of each such cashiers' order shall be HK\$200,000. Each such cashiers' order shall be payable to "Deacons".

除指明的身份證明文件副本外，遞交購樓意向登記表格時必須同時遞交銀行本票。須遞交之銀行本票數目與登記人意欲購買之住宅物業數目相同。每張銀行本票金額為港幣\$200,000。銀行本票抬頭人為「的近律師行」或“Deacons”。

(ii) The completed Registration of Intent shall be submitted at the Sales Office during the period from 23 November 2013 to 26 November 2013 (from 10:00 a.m. to 9:00 p.m., or from 10:00a.m. to 6:00 p.m. on 26 November 2013).
