(2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條，-
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

Purchasers shall pay the Preliminary Deposit (which is equivalent to 5% of Transaction Price) upon signing of the Preliminary Agreement for Sale and Purchase. (4)(iii) 可就購買該項目中的指明住宅物業而連帶獲得的任何贈品、財務優惠或利益
Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the Development

(a) 代繳從價印花稅優惠 “Ad Valorem Stamp Duty ” Benefit:

1. 受限於相關文件條款及條件，買方將享有「代繳從價印花稅優惠」相等於買賣合約之從價印花稅的實際金額或成交金額的 3.75%，以較低者為準。
2. 「代繳從價印花稅優惠」只作繳付買賣合約之從價印花稅之用。
3. 若買方未能按照買賣合約之條款及條件完成住宅物業之買賣或未能按照買賣合約付清成交金額，買方不得享有「代繳從價印花稅優惠」及須應買方要求立即向賣方支付一筆等同賣方較早前已繳付之「代繳從價印花稅優惠」之款項。

2. The “Ad Valorem Stamp Duty Benefit” shall be for the purpose of payment of the ad valorem stamp duty on the agreement for sale and purchase only.
