第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

2. The “Ad Valorem Stamp Duty Benefit” shall be for the purpose of payment of the ad valorem stamp duty on the agreement for sale and purchase only.

3. If the Purchaser fails to complete the purchase of the residential property or fails to pay the balance of the Transaction Price in accordance with the terms and conditions of the agreement for sale and purchase, the Purchaser shall no longer be entitled to the “Ad Valorem Stamp Duty Benefit” and shall forthwith pay to the Vendor an amount equivalent to the “Ad Valorem Stamp Duty Benefit” previously paid by the Vendor on the Vendor’s demand.

4. All the rights and benefits conferred on the Purchaser upon the terms and conditions under this paragraph 4(iii)(a) are non-assignable and non-transferable and can only be exercised and enjoyed by the Purchaser personally.

5. For the avoidance of doubt, it is the duty on the part of the Purchaser to pay all stamp duty, including but not limited to ad valorem stamp duty, buyer stamp duty, additional stamp duty (if any) and penalty imposed by the Stamp Office (if applicable). The “Ad Valorem Stamp Duty Benefit” is only a subsidy offered by the Vendor and the Vendor shall not be liable for any delay in offering the “Ad Valorem Stamp Duty Benefit” in any event.

The Purchaser shall apply to the Vendor's solicitor in writing for the "The Mediterranean Eminent Family Cash Rebate" within 14 days after the date of full payment of the balance of the Transaction Price of the Designated Residential Property and the completion of the purchase of the Designated Residential Property. The Vendor will pay the cash rebate to the Purchaser within 60 days after the Vendor has received the application and duly verified the compliance and fulfillment of all the above terms and conditions by the Purchaser and/or the Related Purchaser and the information in such manner as the Vendor may decide. The benefit is subject to the terms and conditions of the relevant documentation.
