Prospective purchasers are advised to refer to the sales brochure for the Development for information on the Development.

(2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條， -  
According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase- (i) the preliminary agreement is terminated;(ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

If the Purchaser does not choose the Special Benefit as set out in paragraph (4)(ii)(c) upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Ad Valorem Stamp Duty Benefit:

When the Vendor first launches the sale of the Residential Carparking Spaces in the Development, purchasers of those residential properties marked with a "\*\*\*" in Part 2 of this price list will be invited to apply for the purchase of two such Residential Carparking Spaces (on such price as the Vendor prescribes) before the Residential Carparking Spaces in the Development are made available for purchase by other persons. For the avoidance of doubt, if the Purchaser or the Related Purchaser purchased the Related Residential Property and signed the preliminary agreement for sale and purchase thereof before 30 April 2016, the Purchaser shall not be entitled to the "The Mediterranean Eminent Family Cash Rebate"; and
