For the avoidance of doubt, if the Purchaser or the Related Purchaser purchased the Related Residential Property and signed the preliminary agreement for sale and purchase thereof before 30 April 2016, the Purchaser shall not be entitled to the "The Mediterranean Eminent Family Cash Rebate"; and
