第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

(a) 住宅停車位優惠 Offer of Residential Parking Space:

如買方購買有關住宅物業於此價單第二部分標上"*"-之單位，賣方發售發展項目住宅車位時將優先邀請所有該等買方按賣方公布之售價認購一個該等住宅車位。買方須於賣方作出認購邀請時按賣方所訂時限決定是否購買住宅車位，並簽署相關買賣合約，逾時作棄權論。本優惠受相關交易條款及條件限制。

When the Vendor launches the sale of the Residential Carparking Spaces in the Development, Purchasers of those residential properties marked with a "*" in Part 2 of this Price List will be invited to apply for the purchase of one such Residential Carparking Space (on such price as the Vendor prescribes) before the Residential Carparking Spaces in the Development are made available for purchase by other persons. The Purchaser can apply the First Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:
