- (a) Subject to (b) below, an interested person who attends the Sales Office in person between 10:00 a.m. and 10:30 a.m. on the First Date of Sale, i.e. 20 May 2016 (the “**Attendance Registration Period**”) and expresses an interest to purchase a residential property will have the priority to purchase that residential property upon the expiry of the Attendance Registration Period.

於出售首日(即2016年5月20日)上午10時正至上午10時30分(「**報到時段**」)親臨售樓處並表示意欲購買某一住宅物業之人士，將可於報到時段屆滿時優先選購該住宅物業，唯下文(b)段另有規定除外。

- (b) If during the Attendance Registration Period, more than one person attend the Sales Office in person and express the interest to purchase the same residential property, balloting will be used to determine the order of priority in which each of such persons may purchase that residential property.

- (c) After the selection of the residential properties as aforesaid, the remaining residential properties, if any, will be sold on a first come first served basis.
