In the event that any of the specified residential properties offered to be sold under this sales arrangements is sold pursuant to other sales arrangements prior to the first date of the sale hereunder, the relevant specified residential property will cease to be available for the sale under this sales arrangements.

The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender from time to time by amending the sales arrangements.

Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of the Phase of the Development so as to ascertain whether a particular specified residential property is still available for tender on a Date of the Sale. Although a specified residential property may be available for tender on a Date of the Sale, it may become unavailable during that Date of the Sale because the Vendor may accept a tender within the acceptance period after the close of that previous tender exercise. In such event, the Vendor will reject offer(s) for purchase of the relevant specified residential property. Please also note that the register of transactions of the Phase of the Development may not be updated immediately after the Vendor accepts a tender.

The specified residential properties or (if it is not reasonably practicable for the specified residential property(ies) to be viewed by the prospective tenderers) its/their comparable residential property(ies) are available for viewing by prospective tenderers by prior appointment. Prospective tenderers are invited and advised to view the specified residential properties or (if it is not reasonably practicable for the specified residential property(ies) to be viewed by the prospective tenderers) its/their comparable residential property(ies) before submission of tender offer. Notwithstanding the aforesaid, the Vendor reserves the absolute right and discretion to adjust the arrangements applicable to any prospective tenderer for viewing the specified residential properties or (if it is not reasonably practicable for the specified residential property(ies) to be viewed by the prospective tenderers) its/their comparable residential property(ies).

In the case where a Tropical Cyclone Warning Signal No.8 or above is hoisted or Black Rainstorm Warning is issued by the Hong Kong Observatory or “extreme conditions” is announced by the Government of Hong Kong SAR during the Time of the Sale on any Date of the Sale, the tender closing date and time of that Date of the Sale will be postponed to the next calendar date where no

Tropical Cyclone Warning Signal No.8 or above is hoisted or Black Rainstorm Warning is issued by the Hong Kong Observatory or “extreme conditions” is announced by the Government of Hong Kong SAR whilst the tender closing time will remain unchanged on such postponed tender closing date.

The Vendor may from time to time impose health and security related precautionary measures and crowd control at the Sales Office 1 or the Sales Office 2 (as the case may be). Any person who fails to comply with such measures and the direction of the Vendor may be rejected from admitting to the Sales Office 1 or the Sales Office 2 (as the case may be).
