#### Payment Terms of Mayfair By The Sea 8 Parking Spaces

##### 停車位付款計劃

##### Payment Plan of Parking Spaces

- 1 售價10%為臨時訂金，須於簽署臨時合約時繳付。  
10% of the Purchase Price as the deposit shall be payable upon the signing of the preliminary agreement for sale and purchase ("Preliminary Agreement").
- 2 售價90%為售價餘款，須於2022年3月1日完成交易時或之前付清。  
90% of the Purchase Price as the balance of the Purchase Price shall be paid in full upon completion of the sale and purchase on or before 1 March 2022.

#### B. 其他條款及條件

##### Other Terms and Conditions

- 1 所有停車位均以「現狀」發售。賣方建議準買家親身到訪現場了解車位環境。  
All Parking Spaces are sold on "as is" basis. Prospective purchasers are advised by the Vendor to conduct an on-site visit for a better understanding of the Parking Spaces.
- 2 所有按揭之安排以銀行及財務機構之最終批核為準。  
All mortgage arrangements are subject to the final approval of the mortgagee banks and financial institutions.
- 3 每一個停車位只售予於停車位完成交易時為「逸瓏灣8」住宅單位的註冊業主。停車位買方與住宅單位的註冊業主必須相同。  
Each Parking Space shall only be sold to a purchaser who is the registered owner of a residential unit of Mayfair By The Sea 8 at the time of the completion of the sale and purchase of such Parking Space and the purchaser of Parking Space and the registered owner of the said residential unit must be the same person(s).
- 4 停車位於交易完成後以交吉的情況交予買方。  
Vacant possession of the Parking Spaces shall be delivered to the purchaser after completion.
- 5 買賣雙方各自承擔其有關停車位買賣的律師費及其他有關費用。有關停車位買賣的業權契據、文件的核證副本費用、草擬大廈公契及管理協議("公契")費用及附於公契之圖則費用的適當分攤、圖則費及登記費等及所有臨時合約、正式買賣合約及轉讓契的印花稅均由買方負責繳付。  
The purchaser and the Vendor shall bear their own legal fees and other relevant expenses in respect of the sale and purchase of the Parking Spaces. The certified copying charges of title deeds and documents of the Parking Spaces, a due proportion of the costs for the preparation of the Deed of Mutual Covenant and Management Agreement ("DMC") and the plans attached to the DMC, plan fees and registration fees etc. in connection with the sale and purchase of the Parking Spaces and all stamp duties payable on the Preliminary Agreement, the agreement for sale and purchase and the subsequent assignment shall be borne by the purchaser absolutely.

The Vendor and Sino Real Estate Agency Limited reserve all rights to amend the above Payment Terms and Other Terms and Conditions (including but not limited to the right not to accept any offer from the Purchaser to purchase the Parking Spaces).
- 7 賣方將保留不時更改停車位售價之絕對權利。停車位售價如有修改，賣方或信和地產代理有限公司並無責任事先作出通知，而停車位將以賣方最終決定之價格出售。  
The Vendor reserves the absolute right to change the purchase prices of the Parking Spaces from time to time. If there is/are any price adjustment(s) in relation to the Parking Space(s), the Vendor or Sino Real Estate Agency Limited shall not be under any obligation to make any prior notification, and the Parking Space(s) will be sold at the purchase prices as finally determined.
