The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender from time to time by amending the sales arrangements.

Persons interested in submitting tenders of the specified residential properties are reminded to read the latest register of transactions of Phase 1B of GRAND MAYFAIR (GRAND MAYFAIR II) so as to ascertain whether a particular specified residential property is still available for tender on a Date of the Sale. Although a specified residential property may be available for tender on a Date of the Sale, it may become unavailable during that Date of the Sale because the Vendor may accept a tender within the acceptance period after the close of that previous tender exercise. In such event, the Vendor will reject offer(s) for purchase of the relevant specified residential property. Please

also note that the register of transactions of Phase 1B of GRAND MAYFAIR (GRAND MAYFAIR II) may not be updated immediately after the Vendor accepts a tender.

In the case where a Tropical Cyclone Warning Signal No.8 or above is hoisted or Black Rainstorm Warning is issued by the Hone Kong Observatory or “extreme conditions” is announced by the Government of Hong Kong SAR during the Time of the Sale on any Date of the Sale, the tender closing date and time of that Date of the Sale will be postponed to the next calendar date where no Tropical Cyclone Warning Signal No.8 or above is hoisted or Black Rainstorm Warning is issued by the Hone Kong Observatory or “extreme conditions” is announced by the Government of Hong Kong SAR whilst the tender closing time will remain unchanged on such postponed tender closing date.

The Vendor may from time to time impose health and security related precautionary measures and crowd control at the Sales Office. Any person who fails to comply with such measures and the direction of the Vendor may be rejected from admitting to the Sales Office.

In the event of any discrepancy between the English and Chinese versions of this Information on Sales Arrangements, the English version shall prevail.
