第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase - (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

The Purchaser can apply the First Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:

The Purchaser is not required to repay principal and interest for the first TWO years of this First Mortgage Loan. The Purchaser shall have no claims whatsoever against the Vendor as a result of or in connection with the approval and/or disapproval of the First Mortgage Loan and/or any matters relating to the First Mortgage Loan.

(This arrangement is only applicable to Purchasers who choose (D2)150-day Second Mortgage Payment Plan.)

買方可向賣方指定財務機構申請第二按揭貸款。主要條款如下：

The Purchaser can apply the Second Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:

The maximum tenure of the Second Mortgage Loan shall be 20 years or the tenure of first mortgage loan, whichever is shorter. When the Vendor first launches the sale of the residential parking spaces in Phase I and/or Phase II of the Development, Purchaser of residential property marked with a “*” in Part 2 of this Price List (together with other Purchasers who have the same offers under this Price List or other Price List(s) issued or to be issued by the Vendor from time to time) will be invited to apply for the purchase of one residential parking space (on such price and terms as the Vendor may in its absolute discretion prescribes). Purchaser must decide whether to purchase one residential carparking space and must enter into a relevant preliminary agreement for sale and purchase and agreement for sale and purchase within the period as prescribed by the Vendor when the Vendor makes the invitation, failing which the Purchaser will be deemed to have given up the offer and the Vendor will not make any compensation to the Purchaser therefor.
