- (1) 準買家應參閱發展項目的售樓說明書，以了解該項目的資料。

Prospective purchasers are advised to refer to the sales brochure for the Development for information on the Development.

- (2) 根據《一手住宅物業銷售條例》第52(1)條及第53(2)及(3)條，-

According to sections 52(1) and 53(2) and (3) of the Residential Properties (First-hand Sales) Ordinance, -

第52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時，該人須向擁有人支付售價的5%的臨時訂金。

A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

第53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約，並於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則擁有人必須在該日期後的8個工作日內，簽立該買賣合約。

If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

第53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時，但沒有於該日期後的5個工作日內，就有關住宅物業簽立買賣合約，則 - (i) 該臨時合約即告終止；(ii) 有關的臨時訂金即予沒收；及 (iii) 擁有人不得就該人沒有簽立買賣合約而針對該人提出進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase - (i) the preliminary agreement is terminated; (ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

- (3) 實用面積及屬該住宅物業其他指明項目的面積是按《一手住宅物業銷售條例》第8條及附表二第2部的計算得出的。

The saleable area and area of other specified items of the residential property are calculated in accordance with section 8 and Part 2 of Schedule 2 to the Residential Properties (First-hand Sales) Ordinance.

95% of Transaction Price being balance of Transaction Price shall be paid within 120 days after signing of the preliminary agreement for sale and purchase.

買方可向賣方指定財務機構申請第一按揭貸款。主要條款如下:

The Purchaser can apply the First Mortgage Loan from the Vendor's designated financing company. Key terms are as follows:

(1) 買方必須於買賣合約內訂明的付清成交金額餘額之日或發展項目的預計關鍵日期(以較早者為準)前最少60日以書面向指定財務機構申請第一按揭貸款。

The Purchaser shall make a written application to the designated financing company for a First Mortgage Loan in not less than 60 days before the date of full settlement of the balance of the Transaction Price.

(2) 指定財務機構會因應買方及其擔保人(如有)的信貨審查及評估結果,對貸款金額及/或利率作出調整。

In accordance with the result of credit check and assessment of the Purchaser and his/her/its guarantor (if any), the designated financing company will adjust the loan amount and/or the interest rate.

The First Mortgage Loan shall be secured by a first equitable mortgage and/or first legal mortgage over the residential property.

(4) 該住宅物業只可供買方自住。

The residential property shall only be self-occupied by the Purchaser.

(5) 第一按揭貸款金額最高為淨樓價<sup>1</sup>的80%。

The maximum amount of First Mortgage Loan is 80% of the net purchase price<sup>1</sup>.

The Purchaser is not required to repay principal and interest for the first year of the tenure of this First Mortgage Loan. The Purchaser shall only pay the interest to the designated financing company for this First Mortgage Loan for the second year and is not required to repay principal, interest rate of the First Mortgage Loan for the second year shall be at the Prime Rate (P) quoted by the designated financing company from time to time minus 3% per annum (P-3%). The Purchaser shall only pay the interest to the designated financing company for this First Mortgage Loan for the third year and is not required to repay principal, interest rate of the First Mortgage Loan for the third year shall be at the Prime Rate (P) quoted by the designated financing company from time to time minus 2% per annum (P-2%), subject to fluctuation. The final interest rate is subject to the approval of the designated financing company. Prime Rate is quoted by the designated financing company from time to time.

The Purchaser shall repay the First Mortgage Loan by monthly installments.

If the Purchaser shall duly repay the First Mortgage Loan on or before the 360th day after the First Mortgage Loan drawdown date (that is the date of settlement of the balance of the Transaction Price), 0.5% of the First Mortgage Loan amount will be rebated.
